


December 9 was Lisa's last day at the Walla Walla County Conservation District before she transitioned to her new career chapter. You may not have known the many things Lisa did for us over the years, so here are some highlights.

As a Civil Engineering Technician, Lisa worked on numerous irrigation efficiency piping projects. Dozens of miles and many more pump stations later... she drafted hundreds of fish screen and flow meter designs for staff, contractors & landowners. She helped with agricultural burn permit processing including those maps and legal descriptions. Did you record your Township, Range & Section numbers on those forms? If not, Lisa may have helped you. What about recording rainfall information? Lisa collated the rainfall data and maps since 2015.

In the past few years, Lisa coordinated with agencies on restoration projects, such as the McCaw reaches on the Touchet River between Bolles Bridge and Waitsburg. She didn't stop there. The Walla Walla County Conservation District is solely funded by grants. Recently, she expanded her skills into grant writing and secured funds for projects on the Touchet River and Mill Creek.

Vote in our Election!

On February 5th, 2021, the Walla Walla County Conservation District will hold our annual election for an open seat on our board of supervisors. Supervisors are non-partisan public officials that meet monthly to discuss and oversee district activities, policies, finances and provide guidance. They are volunteers who serve without compensation and must reside within District boundaries. Board meetings are held on the evening of the second Monday each month.

Eligible voters are registered voters who reside within the boundaries of the District (outside city limits). Our election will take place via mail-in or drop-off voting.

Ballots can be requested from the District office by calling 509-956-3756, or by contacting any district staff.

The deadline for requesting a ballot is January 20, 2021 at 4:00 PM.

Ballots must be postmarked or returned to WWCCD no later than **February 5, 2021 at 4:00 PM.** Ballots may be dropped in the mailbox located outside of our office at 325 N 13th Ave, Walla Walla, WA 99362.

Water needs

The Walla Walla County Conservation District often works behind the scenes to serve the need of our community. Below is one example. We worked with our partners at WSU and a select few local irrigators in the Fall of 2019 to fine-tune this survey.


We continually seek funding for water efficiency and recharge projects. We participate in many water and stream forums to make sure the natural resources concerns are heard and the challenges private landowners face are dealt with.

Often it takes years to come up with solutions. Stream

projects are no exception. Over the past few years, we heard hundreds of concerns over flooding, erosion and changing river channels. We worked with the Columbia Conservation District, the Snake River Salmon Recovery office, Anchor QEA, and landowners to develop the *Touchet River Conceptual Plan*. This technical document helps us prioritize and accelerate restoration on the Touchet River from Prescott to above Dayton. We have a few other proposals pending for Mill Creek and the Walla Walla River. Nature is outside our control. But we are doing our part to help restore streams, one mile at a time.

WSU launches Water Management Survey in Okanogan, Methow, Walla Walla, Yakima Basins

Do you have views about how water should be managed within your Basin? We want to hear them!

Washington State University scientists and collaborators will survey owners of irrigated farms this winter in the Okanogan, Methow, Walla Walla, and Yakima river basins. Insights from irrigators will help researchers develop innovations to foster water use efficiency for Northwest residents, agriculture, and the environment.

We hope that over time, the results will help you by improving irrigated farming yields and increasing the value and security of water rights. The survey does not ask any questions that would put anyone's water right at risk of relinquishment. All responses will be kept confidential.

Survey Overview

The survey asks people about their use of weather forecasts and how they might best be improved, basic information about their operations, their views on water management policies, and their views and experience with water markets. It will be conducted on behalf of the WSU research team by Pacific Market Research through January 2021.
